Suppressor Purchase Intake Form

About this form. Complete this intake form before your suppressor pickup at Lead Bunker. You can upload it directly during your reservation on the website, bring a printed copy to the shop, or email it to us. This form helps us pre-stage your paperwork so the in-person process is quick.

Important. This is NOT a substitute for ATF Form 4473 or Silencer Shop's official intake. Federal law requires that Form 4473 be completed in person at the FFL — this form is a Lead Bunker prep sheet only. You will still complete the official forms when you come in.

Click YES or NO for each. These are the standard federal disqualifier categories. Answer honestly — knowingly providing false answers on a firearm transfer is itself a federal crime. If you're unsure about any question, ask before signing.
